Community Concepts is a community based 501(c)3 non-profit organization in Maine that has been supporting residents in Androscoggin, Oxford, and Franklin Counties with a dynamic range of services to help strengthen families since 1965.

Community Concepts also fosters economic development in Maine through its wholly-owned subsidiary, Community Concepts Finance Corporation (CCFC). CCFC provides home and business loans and financial coaching and education to help people and businesses realize their financial goals.

One of our proudest achievements was the recognition of our Maine Families Program by the Parents as Teachers National Center with the prestigious Blue Ribbon Affiliation. This endorsement is a testament to our dedication to delivering the highest quality services to children and families through the evidence-based Parents as Teachers home visiting model. Our Maine Families team completed an impressive 3,106 home visits, supporting 253 families with newborns and those expecting a baby. Their tireless efforts in providing guidance, resources, and compassionate support for parents are truly invaluable.

Our commitment to providing affordable housing remains unwavering. Community Concepts Finance Corporation helped 11 families in FY23 achieve the dream of homeownership. We also expanded our maintenance services to assist other housing agencies in Portland, further solidifying our role as a trusted partner in addressing housing challenges—and thanks to a \$150,000 grant from TD Bank, we were able to make critical upgrades to our housing portfolio, improving the quality of life for residents while reducing our carbon footprint.

I encourage you to read more about these stories and the impact of our programs in this report. With our dedicated staff and community partners, we remain committed to empowering individuals, strengthening families, and building vibrant communities and creating lasting, positive change.

OXFORD COUNTY MENTAL HEALTH SERVICES

OFFICIAL PARTNER OF CCI

2023 was the year that CCI made mental wellness and behavioral health an official service priority by partnering with Oxford County Mental Health Services (OCMHS).

The mission of OCMHS is to promote community wellness and empower individuals by providing innovative, person-centered behavioral health services and education. Offering crisis response, behavioral health home services, outpatient therapy, substance use and addiction treatment; several in-house recovery centers, and other services, CCI is moving toward integrating and expanding the services provided by OCMHS throughout CCI's three county service area.

And the need is there. OCMHS saw yet another increase in demand for services in 2023 serving a total of 1,290 clients, with 136 clients being served in the Crisis Residential Unit—and at any given time, there were more than 220 people on waiting lists for services in Oxford, Androscoggin and Franklin counties.

"This partnership with CCI is going to allow us to reach so many more people," said Laura Pepin, Program Manager of the Crisis Residential Unit and other services in Rumford. "CCI is helping us to serve people at the highest standard possible—and provide staff with a cohesive and positive work culture. I am complimented that CCI is coming to us to help us be our best."

One of the services that Pepin oversees is Dialectical Behavior Therapy. DBT is incorporated throughout many aspects of OCMHS programming.

"Everyone who comes to the Crisis Residential Unit is introduced to our DBT group," Pepin said, "Everyone and everyone could benefit from DBT." This is because DBT helps with stress tolerance and emotional regulation and has the overarching goal of helping a person realize their situation and what they can do to move forward. Peer Support Coordinator Jana Mason was referred to DBT when she came to OCMHS for services in 2015. In 2016, OCMHS hired her.

"I benefitted also from counseling, case management, DBT—and through those I was referred to be a peer support specialist," Mason said. "So, I look at myself as someone who is paid to use my lived experience and share that with others to help them grow."

Beacon House - "A Place for Everyone"

Jana Mason works closely with other Peer Support Specialists at The Beacon House in Rumford. Those who stay and visit come from all walks of life, and may be struggling with any number of issues, from lack of shelter to substance use disorder, to personal grief and anguish from loss family or friends.

"We make sure that people here can make informed decisions," Mason said. Part of that is respecting the person's decision on getting help or referral to other resources.

"We're there to support their decision on what they want to do," said Peer Support Specialist Jeanette Jacques, "It's knowing when and how to ask questions when someone says that they are fine and we know that they are not fine."

Jacques has been with OCMHS for 11 years in various roles, with the past 6 years at Beacon House. She says the crucial work is gaining rapport and trust with those staying at the center.

"And we're not just here for people's struggles. We celebrate their victories and the good stuff—whether they reunited with someone, or secured housing—we share that joy together," Jacques said. The mutual support structure instills a sense of community and fosters trust with residents.

"We're here to support them wherever they are in their journey," said Buffy Johnson, Peer Support Specialist, "whether they are struggling with substance use, or if there are no beds available (for crisis) and they are in crisis, we are here for that need—and for them to know that there's always a place in the community for them."

Norway OCMHS Team Provides OPTIONS

While many benefit from referrals that lead them to places like Beacon House or the 4-bed Crisis Residential Unit in Rumford, many who are struggling with substance use disorder or mental illness are harder to reach. That's where the OCMHS Overdose Prevention Through Intensive Outreach Naloxone and Safety (OPTIONS) Team

comes in. Newest to the team is Outreach Clinician and OPTIONS Liaison, Susan Friend.

"We go out and find those who could use resources," Friend said, "a lot of people don't know what is out there for help.

And that there's support available even if they are not ready for huge changes ... part of the outreach is letting them know about that."

Leading the two-person team is Outreach Clinician Coordinator Glenn Gordon, who is in long-term recovery and knows the challenges of reaching those who may not want to be reached.

"There's a window of time. We're making contact as much as we can with folks and sometimes you hit a grand slam," said Gordon. "A first contact, sometimes everything lines up—they want to go somewhere, and resources are available—but often I see it as moving people along from base to base; just getting a sacrifice bunt to get them on first or second base hoping later down the road you can get them across home plate."

Susan realized early on that recovery means something different to everyone.

"Whether it's completely abstaining, or reduction of use. It's whatever you can do with harm reduction and to meet them where they are and what they're willing to do," Friend said.

Whether connecting with people in the field, or in the Crisis Residential Unit, OCMHS staff know of the value that patience and trusted relationships have with clients.

"Our staff make meals and eat with our CRU residents," Pepin said. "It's something so small, but it helps residents see our staff as accessible and trustworthy. It's part of a mutual vulnerability that everyone recognizes and respects."

"And Glenn—his empathy and willingness—he will crawl under a bridge and sit with a person until they are ready to crawl out. People like him, our staff, are a tether for so many people. They are saving lives by being there for them."





VIRTUAL DENTAL HOME PROGRAM

HELPS KIDS IN CCI'S EARLY LEARNING CENTERS

There are many gaps in dental care for children in rural Maine, but CCI's Early Learning Centers are working to change that for families in our Head Start and Early Head Start programs. In the 2022–2023 school year, 154 children received dental checkups as part of a collaborative program with the Children's Oral Health Network of Maine. The Virtual Dental Home (VDH) Pilot Program, being implemented by several teams across the State, is supported at CCI by a community-based hygiene team from Mainely Teeth and a supervising dentist from Community Dental in Farmington.

"Basically, virtual dental is the dental visit, all happening at the child's school, or center in our case," shared Danielle Hamlin, Family Service Manager for CCI's Children's Services Department. "The hygienist comes in, and she does everything she would do if you came into the (dental) office."

Although a dentist is not on-site for the visits, the hygienist working with the children shares photos and notes from each child's checkup with a dentist off-site at Community Dental. Once the dentist reviews each case, a care plan is created and shared with the family to schedule any follow-up care that may be needed.

The lack of availability of pediatric dentistry in rural Maine, including those that accept the Maine Care program, all impact a family's ability to access regular dental care for their children. Cole and Alexander Blauer, whose daughter participates in the VDH program, shared what the opportunity has meant for their family.

"We haven't been able to get our daughter into any sort of dental program because everywhere has been full, and it's given me quite a bit of peace of mind knowing that we can get that care for her," Cole said.

"And it makes it easier for her, too, because it's less scary," shared Alexander. "She's 4; she hasn't been in to see a dentist yet. Dentists can be scary. A lot of adults still have anxiety about it, so for her to see somebody in a place that she already trusts at school—she's here every day—and then to see a dentist is just a normal thing."

Melissa Connery, whose son participates in the VDH program, shared a similar sentiment.

"My son has a lot of issues, he had tonguetied surgery ... he doesn't really like things in his mouth," she shared. "So, when he sees another child [receive a dental checkup] in the safe environment that the school is, that's really helped him. Now he isn't scared of the dentist."

Hamlin says that for some of the children, the virtual visits allow them to complete their check-ups at their own pace.

"One of our students was able to come in and just explore at first, like feel the chair and meet the hygienist, and just do the point where she felt comfortable. And then she said, 'all done,' and she came out," Danielle explained. "It's something that you wouldn't do at a traditional office because once your appointment is done, your appointment is done."

The VDH program is offered to any family working with CCI's Head Start or Early Head Start program who indicates that they do not have a dental home. Currently, one hygienist is rotating through CCI's Early Learning Centers, seeing all children signed up for the program.

"We're hoping it will follow school systems, so when these kids go from our Pre-K to Kindergarten, the schools will pick it up... the following year we can expand it to Kindergarten and then just keep going," Danielle said.

CLOSING ON A HOME OPENING A BUSINESS

Securing a home
has now allowed
the brothers
to pursue another
dream: opening
and operating a
food truck business.

Jeremiah and John Johnson have lived in their home in Jay since around Christmastime 2023, when they closed on their house with the assistance of the Community Concepts Finance Corporation. The 22-year-old twin brothers came to CCFC seeking a business loan, though after consultation and advice, the entrepreneurial siblings found that it might be easier to secure housing as a major life asset on their journey to opening a food truck business.

"We always wanted to own a house. It just doesn't make sense starting out now, compared to renting—paying for something that you don't own," Jeremiah said.

The brothers co-signed a loan through CCFC after finding initial down payments with traditional banks too steep for their budget.

"Working with the Financial Corporation, we were so happy with how they helped us secure a house," John said,

"getting things lined up with inspections everything. Now we have a home with three bedrooms with a finished basement."

The Johnson brothers still faced many of the same challenges any prospective homeowner faces, and that includes bidding wars with cash buyers and out-of-state investors.

"We looked at a dozen homes and would always get outbid," Jeremiah said, "but CCFC helped us with where we should be looking. (CCFC's) Natalie Beale was so helpful. She helped us figure out everything."

Securing a home has now allowed the brothers to pursue another dream: opening and operating a food truck business. Over the past three years, both brothers have been commuting to Lewiston for work; the move to have a mobile food truck and serve customers close to home would be another dream come true.

"We formed an LLC for a food truck— JJ's Grill," Jeremiah said.

The plan is for pub- and fair-style food right from the truck window, enabled with a few key investments.

"We found a truck online, had some cash saved and bought it along with a pizza oven and potato slicer that slices them into spirals," John said. Wood-fired pizza and fried potatoes on a stick are just the kind of starchy comfort food the brothers believe will be a hit in the region. And with all that alliteration, their name and brand should prove a memorable one in the minds of customers when JJ's Grill opens in Jay.

MAINE FAMILIES RECEIVES BLUE RIBBON DESIGNATION

Home Visitors with CCI's Maine
Families Program completed more
than 3,000 visits in FY23, supporting
parents with newborns and families
expecting a baby.

Following the Parents as Teachers evidence-based home visiting model, Maine Families Home Visitors help parents with questions, concerns, and general support surrounding several key areas including health, child development, and overall well being. In October 2022, CCI's Maine Families Program was honored to receive a Blue Ribbon Affiliation from the

Parents as Teachers National Center, Inc., a prestigious endorsement marking the program as one of the top-performing home visiting affiliates within Parents as Teachers' international network.

"To earn the Blue Ribbon Endorsement, we underwent a rigorous self study and review process from the National Center. The process confirms that we are meeting Parents as Teachers' standards of fidelity and quality," said Mary-Rita Reinhard, CCI's Chief Operating Officer. "Blue Ribbon Affiliates are exemplary programs, delivering the highest quality services to children and families."

"We are proud to receive the Blue Ribbon designation by Parents as Teachers," said Melissa Wakefield, CCI's Maine Families Program Manager. "This designation represents the dedication that we have in providing the highest quality services available through the Parents as Teachers model."

CCI's Maine Families program serves residents in Androscoggin, Oxford, and Northern Cumberland Counties. In addition to home visits, the program also offers group connections, child screening, and connections to community resources. For families who are expecting, Home Visitors support parents in having healthy pregnancies by providing information about fetal development and childbirth, as well as breastfeeding and nutrition tips. For parents with newborns, Home Visitors share information on what to expect at different ages and stages of a baby's development, provide helpful tools and ideas to meet the daily challenges of parenting, and help parents connect with other community services and resources for additional support.

"Our Maine Families Home Visitors are here to help," shared Reinhard. "Parenting can be difficult, and our team works every day to ensure that families feel the support of their community and have the tools and resources that are crucial to raising children who are happy, healthy, and ready to succeed."

To receive the Blue Ribbon Affiliation from Parents as Teachers', CCI's Maine Families Program not only demonstrated the program's success in accomplishing its goals and intended outcomes, but also verified the program's accountability and credibility to our community, funders, elected officials, and partner organizations.

"This truly is an amazing team that I am proud to be a part of," shared Wakefield. "Each and every day we are all honored and humbled that so many families invite us to share in the joys and challenges of their families! There is no other job that is as rewarding."

PROPERTY MANAGEMENT

TD BANK GRANT MONEY ENABLES HOUSING REHAB

In addition to projects in South Paris, CCI's Property Management program also expanded work in Portland.



When Community Concepts' Property Management Department assessed the status of the agency's Community Lane housing units in South Paris, staff found oil-burning boilers that weren't operating to full capacity and had long surpassed their life expectancy since the opening of the apartments in 1999. And when staff looked at the Maple Street Housing Development in Lewiston, which opened in 2004, employees saw serious weatherization issues that could be remedied with new roofing. Thanks to a \$150,000 grant from TD Bank's Charitable Foundation, units at both locations would soon be back in proper shape for residents.

"This grant allowed successful rehabilitation of these housing units, providing a better quality of life to residents, reducing greenhouse gas emissions, and increasing the financial viability of the housing portfolio," said CCI CEO Jim Martin.

Contractors with AirServ delivered and installed new Energy Kinetics propane boilers, increasing the heating efficiency from 82 to 92 percent, a notable cost savings that further advanced CCI's mission of reducing the carbon footprint of the agency's housing portfolio.

"These propane boilers are made in America and guaranteed for 10 years, so this was a great upgrade," said Director of Property Management, John Fitzmorris. "And as for the three roofs in the Maple Street housing units that needed attention, we were able to replace all of them. This is future-proofing the weatherization needs there for another 30+ years. That is an outstanding expansion of longevity to these units."

CCI's affordable housing portfolio consists of 202 units across
Androscoggin, Franklin and Oxford
Counties. Every upgrade, improvement, and maintenance project makes a difference as housing is one of the biggest challenges facing the state of Maine—and one of the most important assets and services CCI can provide to residents.

"We have an aging housing portfolio and with the restrictions in place to keep them affordable it can be very difficult to address some of the aging building systems and infrastructure within the properties operating budget," said Community Concepts Finance Corporation Asset Manager, Arin Angel.

"It is great that companies like TD Bank recognize that need and have been very generous in supporting our housing programs so that we are able to properly maintain these properties and keep them affordable for the residents of the communities that we serve."

Maintenance staff added in Portland

The demand for assisting other housing agencies in maintenance, repair, and preparation work on housing units in Portland was so great that CCI hired an additional staff member to help with the work.

"Everything from complete kitchen remodels, preparing new move in, preparing houses to be sold, or clean outs or emergency repairs—we do it all. And we have the expert help to supply to these folks who ask for it when they need it," said Fitzmorris.






